

ABORTION ISSUES POLL January 2017

CLIENT: Abortion Law Reform Association of New Zealand

POLL DATES: Sun 22 to Mon 30 January 2017. The median response was

collected on Thu 26 January 2017.

TARGET POPULATION: Eligible New Zealand voters.

SAMPLE POPULATION: Eligible New Zealand voters who are contactable on a landline.

SAMPLE SIZE: 1,000 respondents agreed to participate.

SAMPLE SELECTION: A random selection of 15,000 nationwide phone numbers.

WEIGHTING: The results are weighted to reflect the overall voting adult

population in terms of gender, age, and area.

SAMPLE ERROR: Based on this sample of 1,000 respondents, the maximum

sampling error (for a result of 50%) is +/- 3.1%, at the 95%

confidence level.

CODE COMPLIANCE: This poll was conducted in accordance with the New Zealand

Political Polling Code, the Research Association New Zealand

Code of Practice and the International Chamber of

Commerce/European Society for Opinion and Market Research

Code on Market and Social Research.





Executive Summary

- Only 14% of adults correctly estimated that around one in four women have had an abortion. 37% thought the prevalence rate was under 20% while 19% thought it was over 30%
- A majority of New Zealanders supported abortion being legal in all seven specific circumstances given to them.
- The net level of support (those saying legal less those saying illegal for each circumstance was:
 - Pregnant woman likely to die +72%
 - Foetus has no chance of survival +70%
 - Pregnant woman likely to be permanently harmed +70%
 - Pregnancy is a result of rape +65%
 - Pregnancy is a result of birth control failure +31%
 - Pregnant mother can't afford to have another child +27%
 - Pregnant woman doesn't want to be a mother +22%
- Men are less supportive of the legality of abortion where there is no physical harm to the health of the mother
- Over 60s are less supportive of the legality of abortion than other age groups
- There is little variation by area when it comes to views on abortion
- Pacific Island respondents were overall less supportive of the legality of abortion
- Green party voters were most supportive of the legality of abortion, followed by Labour voters then National voters and least supportive were NZ First voters



What percentage of women in New Zealand have had an abortion would you estimate? Is it under 10%, 10% to 19%, 20% to 29%, 30% to 39%, 40% to 59% or over 50%?

Only 14% correctly estimated that 20% to 29% of New Zealand women have had an abortion. 37% thought the prevalence was less than this and 19% thought the prevalence was greater with 30% unsure.

- 3. Pregnant woman likely to be permanently harmed 6%
- 4. Pregnancy is a result of rape 8%
- 5. Pregnancy is a result of birth control failure 24%
- 6. Pregnant mother can't afford to have another child 27%
- 7. Pregnant woman doesn't want to be a mother 29%
